RULES

Any division with less than 3 competitors may be combined with another division.

- KATA**
1. May perform any kata; tiebreaker must be a different kata. Beginner division may repeat kata.
 2. For black belt kata divisions 73 & 81 must be a minimum of 16 years of age.

KUMITE WKF rules with the following modifications:

| 4. Adults (except WKF Div) | 2 minutes stop time, 8 point ceiling |

WKF Rules for adult advanced divisions 18+

- KOBUDO** All weapons will be subject to inspection by judges before competition.
 Modified weapons or weapons that do not meet tournament criteria may not be used in competition.
 6 ft. Bo must weigh at least 900 grams.
 Weapons must remain in the competitor's hands at all times. Loss of control will result in disqualification.
 Definitions--Long (Bo or Eku) Short (Sai or Tonfa)

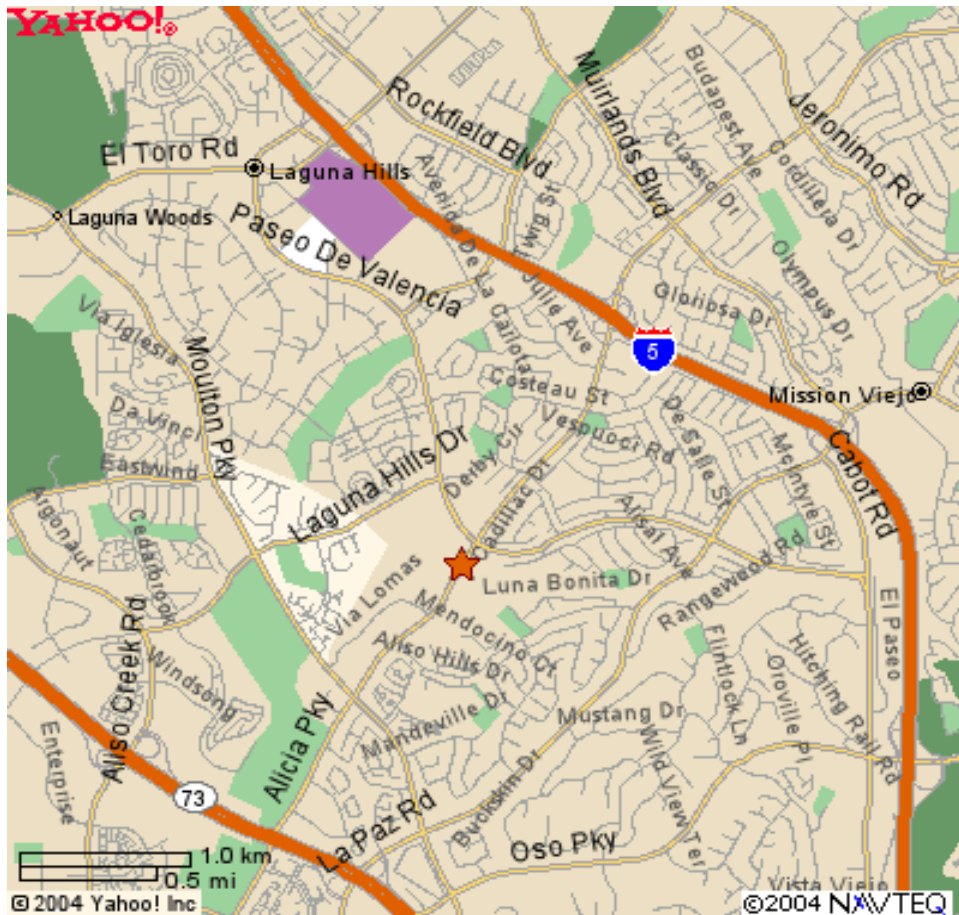
