KARATE-DO CHAMPIONSHIP RULES

Κάτα

Any division with less than 3 competitors may be combined with another division.

- 1. Flag system will be utilized in all matches.
- 2. Beginner and Novice divisions must perform a basic kata. Intermediate and Advanced divisions can perform any kata.
- 3. All kata divisions will have two competitors perform kata at the same time.
- 4. Beginner and Novice kata division competitors may repeat their katas each round.
- 5. For all medal rounds, Intermediate and Advanced divisions must perform a kata different from the previous round.
- 6. Intermediate divisions may not perform any of the following kata:

Киміте

Any division with less than 3 competitors may be combined with another division.

- 1. Modified WKF/USANKF rules will be utilized.
- 2. All divisions will use 2-4 Judges and a Referee.
- 3. If two Judges are used, the Referee will have a vote. The Referee will signal her/his opinion immediately after Yame, when appropriate. The Referee's vote will have the same weight as a Judge's.
- 4. Two votes will be required for points, warnings, and penalties.
- 5. All matches will have a maximum of 8 points, with the exception of Divisions 72 & 80, in which an 8 point lead is necessary to win or have the most points at time.
- 6. All matches will be a maximum of 1 ¹/₂ minutes, stop time, with the exception of Divisions 72 & 80, which will run for 2 minutes.
- 7. Mandatory equipment:
 - A. All competitors must wear a white gi with a belt.
 - B. Only females may and must wear an undershirt.
 - C. All kumite competitors must wear a mouthpiece, and hand protectors white or red/blue gloves.
 - D. All males competitors must wear a groin cup for kumite divisions.
 - E. Shin & foot protectors, head gear, chest guard or body protectors are optional.

Ковидо

- 1. Point system will be utilized.
- 2. All weapons will be subject to inspection by judges before competition. Modified weapons or weapons that do not meet tournament criteria may not be used in competition.
- 3. Bo must be 6 ft and weight at least 900 grams.
- 4. Weapons must remain in the competitor's hands at all times. Loss of control will result in disqualification.
- 5. Definitions Long (bo or eku) Short (sai, nunchaku or tonfa)

Теам Ката

- 1. Flag system will be utilized.
- 2. Three people per team, female, male, or mixed.
- 3. All team members must perform the same kata.
- 4. All team members must start facing the same direction.
- 5. No bunkai to be performed and each team will perform kata one at a time.
