# 26th Annual USA Wado Ryu KARATE-DO CHAMPIONSHIP RULES

## KUMITE

Any division with less than 3 competitors may be combined with another division.

1. Modified WKF/USANKF rules will be utilized.
2. All divisions will use 2-4 Judges and a Referee.
3. If two Judges are used, the Referee will have a vote. The Referee will signal her/his opinion immediately after Yame, when appropriate. The Referee's vote will have the same weight as a Judge's.
4. Two votes will be required for points, warnings, and penalties.
5. All matches will have a maximum of 8 points, with the exception of Divisions 88 & 96, in which an 8 point lead is necessary to win or have the most points at time.
6. All matches will be a maximum of 1 ½ minutes, stop time, with the exception of Divisions 88 & 96, which will run for 3 minutes.
7. Mandatory equipment:
  - A. All competitors must wear a white gi with a belt.
  - B. Only females may and must wear an undershirt.
  - C. All kumite competitors must wear a mouthpiece, and hand protectors - white or red/blue gloves.
  - D. All males competitors must wear a groin cup for kumite divisions.
  - E. Shin & foot protectors, head gear, chest guard or body protectors are optional.

## KOBUDO

1. Point system will be utilized.
2. All weapons will be subject to inspection by judges before competition. Modified weapons or weapons that do not meet tournament criteria may not be used in competition.
3. Weapons must remain in the competitor's hands at all times. Loss of control will result in disqualification.
4. Definitions – Long (bo or eku) Short (sai, nunchaku or tonfa)

## KATA

Any division with less than 3 competitors may be combined with another division.

1. Flag system will be utilized in all matches.
2. Beginner and Novice divisions must perform a basic kata. Intermediate and Advanced divisions can perform any kata.
3. All kata divisions will have two competitors perform kata at the same time.
4. For all medal rounds, Intermediate and Advanced divisions must perform a kata different from the previous round.

## TEAM KATA

1. Flag system will be utilized.
2. Three people per team, female, male, or mixed.
3. All team members must perform the same kata.
4. All team members must start facing the same direction.

In consideration of being allowed to participate in any way in the 2024 USA Wado Ryu Karate-Do Championship athletics/sports program, and related events and activities, the undersigned:

1. Agrees that prior to participating, they know and understand the Rules of Competition, and that they (if under 18 years of age a Parent or Guardian) will inspect the facilities and equipment to be used, and if the participant and/or Parent or Guardian, believes anything is, or may be, unsafe, they will immediately advise their coach or supervisor and the 2024 USA Wado Ryu Karate-Do Championship personnel of such condition(s) and refuse to participate unless and until such condition is remedied.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inaction's or negligence but the actions, inaction's or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. The undersigned assumes all the foregoing risks and accepts personal responsibility for the damages following such an injury, permanent disability or death.
3. Release, waive, discharge and covenant not to sue Wado Ryu USA, 2024 USA Wado Ryu Karate-Do Championship, Capo Valley High School, Gymnasium, regional sports organizations, their respective administrators, directors, agents, coaches and other employees, staff, official and volunteers of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of premises used to conduct the event, all of which are hereinafter referred to as "releases" from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.
